



## **Interim Report on Hurricane Melissa Relief Fundraising Campaign**

**Date: December 31, 2025**

### **Timeline:**

28. October 2025	Hurricane Melissa hits Jamaica
4. November 2025	E.W.F. and Peacemakers are launching the WhatsApp group "RASTAFARI MELISSA DISASTER MAPPING". This group will collect and record information and locations of all Rastafari Elders and communities in Jamaica.
11. November 2025	R.U.N. members make first private remittances to Jamaica
11. November 2025	Initial aid packages will be distributed based on the information gathered.
20. November 2025	RUN is launching the GoFundme campaign "Hurricane Melissa Relief" with the goal of raising CHF 100,000.
December 2025	Two reggae events in Bern (CH) and Lyon (FR) are raising money for the GoFundme campaign.

### **Further action by EWF and Peacemakers**

- Complete mapping and deliver further aid packages.
- Begin rebuilding destroyed homes and community centers.
- Begin rebuilding food production (gardens and farms).

### **Summary of interim report:**

Shortly after the horrific event of November 28th, it became clear that the Jamaican government was unable to send aid to the remote regions of the island in time. Many Rastafari communities, who have lived in the hills of Jamaica for many years, were and still are particularly hard hit.

A lack of communication, blocked access roads, and completely destroyed food production facilities made the already difficult daily life after the storm even harder for these people. This was due to a lack of access to medicine and food, as well as the inability of many to contact friends and family.

Thanks to the rapid response of the Peacemakers and the EWF on the ground, it was quickly possible to overcome the initial shock and gather enough resources to begin work on the Hurricane Melissa Relief Project. This means that just a few days after the hurricane, the first emergency packages were delivered, and relatives reported missing persons. These individuals were located and also provided with emergency aid packages.

In a second phase, support is now being provided for the construction of houses, farms, and community centers, and preparations are already underway to ensure an even faster response in the event of another disaster.

RUN's rapid financial support provided the necessary framework and helped boost the motivation of everyone involved.
